## Vestry Meeting March 16, 2016

Meeting opened with prayer at 6:55 p.m. Joe moved and Charlie seconded to accept agenda as amended; motion carried.

The March minutes are amended to include the information that Eaton Camp will be kindergartners only and a maximum of 25 children. Carol moved and Patty seconded to accept minutes as amended; motion carried.

## I. Warden Report

- A. Fr. Jerre Feagin will be out for the month of April for surgery and will return thereafter on a month-to-month basis. On April 3 and 17, Archdeacon Tom Tripp will be here; reserved sacrament will be used. April 10 will be a shared service at 4:30 p.m. with Ascension. Vicki Zust will celebrate on the 24<sup>th</sup>.
- B. Eaton Camp arrangements are all set. Carol moved that we make our Easter offering this year the donation of our space to the Eaton Camp; Katie seconded; and motion carried.
- C. It was noted that until profiles are completed, it is not known whether Good Shepherd and Ascension will be searching with us for a rector, or separately.
- D. Laurie Ousley, chair of the PCA Garden Walk, has requested to use the front lawn. Date is June 26, 10-4.
- E. Debbie reported that Easter Egg Hunt is noon on Saturday before Easter, 3/26.
- F. Pat Lalonde has requested that the wardens have check-signing authority. Patty so moved, Debbie seconded, and motion carried. Patty did note that authorizers and check-signers must not be the same person.

## II. NEW/OLD BUSINESS

Carol reported on developing Profile. Vicki Zust has been advising. Profile should be online and approximately 8-9 pages. Focus groups are recommended. Susan Woods will serve as facilitator.
